Grievance Redressal Cell-

The Grievance Redressal Cell (GRC) constituted for the purpose of redressal of grievance students. The students may express their grievance by approaching the members of the cell and express their grievances. The students are also encouraged to make constructive suggestions by using the suggestion box. The college assures the students that once a complaint is made, it will be treated with sensitivity and as confidential.


Grievance Redressal Cell deals with the following matters:-

1. Grievance of students
2. Complaints of ragging
3. Complaints of violation of norms & standard in the campus
4. Internal complaints committee for women.

The GRC shall, upon receipt of the complaint will conduct an inquiry and submit the inquiry report within a week.

1. Anyone found guilty of sexual harassment shall be punished in accordance with the policy of Internal Grievances Cell for Sexual Harassment against Women at Working Place.
2. Where the respondent is a student, depending upon the severity of the offense, the principal may;
 - a) Withhold privileges of the student such as access to the library, auditorium, halls residence, transportation, scholarship, and identity card.
 - b) Suspend or restrict entry into the campus for a specific period.

- c) Expel and strike off name from the rolls of institution, including denial of re-admission, if the offense so warrants.
- d) Award reformatory punishments like mandatory counseling or performance of Community service.
